Similarly, pride within the Church today can lead to unnecessary divisions over non-essential matters, creating an environment where humility and cooperation are replaced with self-righteousness and exclusion.

2. Fear: Concern Over Theological Purity or Loss of Identity

Churches and denominations often fear that engaging with others who hold different beliefs will compromise their theological purity or lead to the erosion of their identity.
