teaching that *“all those who exalt themselves will be humbled, and those who humble themselves will be exalted.”*

True humility recognizes that all people are equally dependent on God’s grace. Avoiding the ego trap requires a shift from self-righteousness to a posture of openness, empathy, and self-awareness, allowing believers to engage with others without condescension or judgment.
